## NOTIFICATION

In the interest of Public Service, all National Disease Control Programmes (NDCPs) shall henceforth provide relevant Medicine, Reagents and other logistics & Consumables to various Health Units as provided for in the programme including the Mobile Units (MMU/Mobile ICTC etc) with immediate effect.

- 2. The Health Unit/Mobile medical unit/Mobile ICTC shall requisition to the respective District Programme Officer its requirements and also submit Monthly Report of the activity as per the requirement of the Programme. Shortage of such items should be immediately brought to the notice of the CMO and the Principal Director.
- The District Programme Officer shall be responsible for monitoring and supervision for ensuring delivery of quality services.
- 4. All such services- Investigation & Treatment including Routine Immunization (eg: Test for malaria, TB, VDRL or Medicine for Malaria, TB, Leprosy, RTI/STI etc) as per the Programme Guideline shall be delivered Free of Cost and Collection of User Fees by the Health Unit on such services strictly PROHIBITED with immediate effect.
- 5. All Health Unit shall mandatorily display at a prominent place the availability of such Free Services.
