NO. Med-1/3/73(Pt-II)/2001 : : In order to regulate setting up of Private Hospitals, Nursing Homes, Clinics and other such Centres catering to Diagnostic, Investigative, Operative and other Health Care Services and to maintain Quality Control over the services rendered by such Centres, and, in exercise of the Power conferred vide Section 4 (i) of "The Nagaland Health Care Establishments Bill, 1997", the State Government hereby constitute an Authority called "The Nagaland Health-Care Establishments Authority" consisting of the following nine members, namely:

a.	Secretary, Health and Family Welfare	: :	Chairman
b.	Secretary, Justice and Law	: :	Member Secretary
c.	Director, Medical services	: :	Member
d.	Additional Director Health services	: :	Member
e.	Additional Director Medical Services	: :	Member
f.	State Nursing Superintendent	: :	Member
g.	Representative from Administration	: :	Member
h.	Representative from Local Body to be nominated by Government	: :	Member
i.	Representative from Private Practitioner	: :	Member.

Jurisdiction :

The jurisdiction of the Authority shall extend over the entire State of Nagaland.

Powers, Duties and Functions of the Authority :

Without derogation to any law for the time being in force and without prejudice to the generality of its powers and functions the Authority shall:-

- (i). Receive applications for grant of licensing or registration of Nursing Homes, clinics;
- (ii). Scrutinize the applications and call for further information or particulars from the applicants or from any other person or Authority as may be required;
- (iii). Consider the applications and pass orders ;
- (iv). and do such other things as are required or incidental for the purpose.

This Notification will come into force with immediate effect.
